

NOTE: >All Dogs and Cats over 4 months of age must be vaccinated against rabies, and licensed
 >The fine for an unvaccinated pet is \$500; the fine for an unlicensed pet is \$100
 >Please make your check or money order payable to Montgomery County
 >A RABIES CERTIFICATE MUST BE SUBMITTED WITH THIS APPLICATION

1. **IF YOUR PET IS NOT ALTERED** (Spayed or Neutered) and over one year old, you must license your pet through the expiration date of the current rabies vaccination, up to three years. Check the expiration date of your pet's rabies certificate and pay the fee below:

If Rabies Vaccination expires in 2 to 12 Months, the fee is \$25.00; 13 to 24 Months, the fee is \$50.00; 25 to 36 Months, the fee is \$75.00

NOTE: If your payment is less than the amount required to license your pet to the expiration date of the rabies vaccination, the application will be returned to you for additional payment. (A pro-rated refund is available to you if your pet is altered during the licensing period, send proof of altering and pet's license tag number).

2. **IF YOUR PET IS ALTERED** (Spay/Neuter Certificate must be submitted, or Spay/Neuter Affidavit on front of this application must be signed): The fee is \$12.00 for 1 year, \$24.00 for 2 years, and \$32.00 for 3 years (Recent 3-yr rabies vaccination required for 3-yr license)

3. **REDUCED FEE LICENSE:** Public Assistance recipients only, and only for altered pets. Proof of Altering and Public Assistance is required, see front of this form. The fee is \$6.00 for one year; \$12.00 for 2 years, and \$16.00 for 3 years (Recent 3 year rabies vaccination required for 3 year license).

4. **JUVENILE LICENSE:** Pets under 1 year old, altered or not – this license will expire one year from date of pet's first rabies vaccination. There is no charge for this license, but the rabies certificate must indicate the pet is under one year old.

5. **REPLACEMENT TAG:** Call the Licensing Office for a replacement, or send your name, address and pet's name to the address below to receive a new license tag.
